That the organisation "KRIYAYOGA FOUNDATION TRUST" is a Society running its operation in the state of Odisha since 17th April'1979 vide registration number 15252/89 of 1979-80 by the Registrar of Societies, Orissa. Having its operation for the Spiritual, Educational, Charitable, Social, Cultural, and Health activities, it has served and helped the public of the state and country at large.


1. **Name** : The name of the society shall continue to be "KRIYAYOGA FOUNDATION TRUST". herein after it is called as " Society".
2. (a) Registered office : The Registered office of the Society shall continue to be situated at Kriya Yoga Ashram, VSS Nagar, PS- Sahidnagar, Bhubaneswar-751010, Odisha (India) or at any other place as shall be decided by the General Body of the Society.

(b) Area of Operation : The Area of Operation of the society shall continue to be in the state of ODISHA and other of places.

3. **OBJECTIVES :**

The objectives of the organisation shall continue to be as follows:

- a) To propagate Yoga & Meditation including Kriya yoga by establishing Ashrams, practice pyramids, Yoga centres and meditation centres in any part of the world,
- b) To impart practical lessons, trainings, guidance on Yoga and Meditation by organizing workshops, symposium and conferences to further the cause of Kriya Yoga in particular and Spirituality in general,
- c) To support and promote the advancement of educational activities in all its branches, such as Kindergarten, Primary, Middle and High Schools, College, universities leading up to and teaching Diploma, Degree, Post Graduate and Doctorate course in Arts, Science, Commerce, Engineering, Medicine, Pharmacy, Dental, Nursing, Nursery Teachers Education, Management, Bio technology, Music and Fine arts, Architecture and to impart industrial training and vocational training in the field of production & process, medical technology, science to develop other industrial activities and also such other subjects as the Board of Societies may deem fit for the benefit of the Student of all castes and communities, both from Indja and outside.



- d) To enter into technical and financial arrangement with national and international agencies and institution for exchange of knowledge by study tours, training in specialised area of science & technology, conducting joint projects, providing technical assistance in the establishment of scientific institutions and for other matters consistent with the aims and objectives of the Society.
- e) To make planning and development of Institutionalized Education in accordance with the directives given by the competent authorities of the Education Department, Director of Technical Education, Medical Education and / or other Govt. Depts., Universities in Odisha / other states in India or abroad from time to time.
- f) To carry out plantation , afforestation, agriculture promotion, horticulture, vermiculture, sericulture, pisciculture, herbiculture, horticulture, medicinal plantation, animal husbandry, animal welfare and do awareness program among the people for making the country green by adopting all right means.
- g) To organise Social Help Group in urban and rural areas for the benefit of weaker section community of Odisha & India including women groups for the right and responsibilities of women in the social development.
- h) To carry out activities relating to pollution control of all types including air, water and on and above of the environment and/or to create awareness among the people about this for saving the world at large.
- i) To provide and /or render services for resolving any family, village, disputes relating to social affairs, agriculture, civil acts, general administration, property separations among the villagers and others on request by the members by compromise settlement to maintain harmony, discipline and order in the village before going to Police or Court.
- j) To take such action as may be necessary activities like plantation, women & child welfare, blindness control and aid to physically handicapped, hearing aid programs, to carry on activities of the Society with other Societies and Organization with similar objectives.
- k) To conduct research studies on the social a economic conditions of people with a view to involving ways and means for their development with in their social historical frame works and to seek promotion of rural development such as provision of drinking water, rural industrialization as well as Public Convenience for people.
- l) To take up activities in the line of health care of people by way of setting up hospitals, Nursing homes, diagnostic centers, pathological laboratories, in the line of modern medicine, allopathy, Ayurveda, homeopath, Ayush, Alternative Medicines both online and offline modes for the ultimate benefit of the society at large and to establish newly or by take over provide, endow,

equip, furnish, maintain, develop, control, manage and conduct hospitals in all or any of their departments and functions for providing medical, surgical and nursing care of treatment for indoor and out door patients, and such other institutions, as the Society may deem necessary or convenient for any of its purpose, all of which are charitable and not an activity of sole profit.

- m) To explore ways for promotion of socioeconomic development in the community including to work for the improvement of the standard of social welfare activities in the State & the nation and to take up programs, activities for plantation, health camps, sanitation, rural employment, self help groups, the rehabilitation of victims of natural/ un-natural calamities and neglected sector of the society. To take up relief operation at the time of any natural calamities, rehabilitation programs, self sufficiency to the affected people for help to poor and for Economical Back ward Classes.
- n) To bring the society one step ahead by taking up adult literacy programs, training programs on music, art, songs, lyrics, dance and bhajans and creating Old age homes, shelter for orphanage & destitute, hospice homes, geriatric homes and self employment programs for youths.
- o) To promote charitable activities including in the fields of literature, science, art, health, education and culture.
- p) To undertake, organize, conduct and facilitate, Courses, conference, lecture, research and education on various aspects and of science, technology, mythology, Veda, Vedanta, Upanishads, Culture, Development of Society and other fields.
- q) To train the downtrodden people in general for human resource development in view of the emerging needs such as database development, resources survey methodologies, computer, environmental, quantum, Bio atomic, studies, health, education, and energy problems of all types including hydro, solar, thermal, wind and other alternative energy.
- r) To undertake activities of providing education to all sections of the society and to provide the basic requirement for education them and to promote literature in the society by bringing awareness among the common people by organising meetings and awareness camps and by adoption of some segment of the society.
- s) To undertake and promote the publication & translation of journal, research papers and books and to develop the audio-visual programme to disseminate knowledge pertaining to the objectives of the Society and to Print, Publish, Sponsor & Distribute reports, Books, Monographs, Periodicals, news papers in India or outside & other publication for meetings the objects of the Society and to develop library in all levels with collection of different books for the benefit of the members and villagers at large.



- bb) To take such steps by personal or written appeals, or by advertisement otherwise ,as may be deemed expedient ,for the purpose of publishing the functions and activities of the Society, or of procuring contributions to the funds of the Society in the shape of donations, subscriptions or otherwise to make, enact, alter, amend, repeal, re-enact and enforce rules and regulations from time to time for the management and conduct of the work, business, departments, offices and affairs of the Society and in respect of qualifications , classes, conduct, functions, duties, remuneration and privileges of its works ,institutions, activities or functions.



- cc) To issue appeals and make applications for raising money and funds in furtherance of the objectives and to accept gifts, donations, and subscriptions of cash and securities and of any property either movable or immovable from within or any outside the country and to utilise the same for the purpose for which the amount was received.
- dd) To invest and deal with funds and money of the society in mutual funds, shares, bonds, deposits, debentures, etc. of Insurance Companies, FIs & recognised organisations including co-operative organisations etc, acquire, purchase, or otherwise own or take on lease or higher in state of Odisha or outside temporarily or permanently any movable or immovable property necessary or convenient for the furtherance of the Society.
- ee) To build and or take lease any immovable property and make all types of use of the same from private persons, government, corporations etc. for the benefit of the members and for the achievement of the objects of the Society/organisation.
- ff) To sell, lease, mortgage, give on rent, exchange, and otherwise transfer all or any of the properties of Society for the general interest of the Society and for furtherance of the objective of the Society/ society, in the form of taking loan from banks/FIs or other bodies by mortgage of the properties of the society.
- gg) To undertake such other activities not specifically mentioned here above in the interest of achievements of the aims and objectives of the Society as decided by the Governing Body from time to time, where all such things as are incidental, instrumental and conducive for the attainment of the aims and objects of the Society enumerated above.
- hh) To borrow money or receive money or deposit upon such terms, funds and assets of the Society, as the management of Society shall deem necessary or expedient for the fulfillment of the objects of the Society.
- ii) To negotiate and enter into the agreement with any government, University Municipality or any other public or private authority, which may seem conducive or beneficial, improved or rendered more efficient, work or activity of the Society.
- jj) To purchase, take on lease or in exchange or otherwise acquire any movable or immovable property which may be deemed necessary, expedient, and desirable for any objects of the Society.

RULES AND REGULATIONS
OF
KRIYAYOGA FOUNDATION TRUST

1. Short Title :

These rules and regulations may be called the rules and regulations of the "KRIYAYOGA FOUNDATION TRUST".

2. Office of the Society :

The Office of the society shall be situated at Kriya Yoga Ashram, VSS Nagar, PS-Sahidnagar, Bhubaneswar-751010, Odisha. (India) or places as the Governing Body may decide.

3. Interpretation :

Under these Rules :-


- i) The Society means the "KRIYAYOGA FOUNDATION TRUST"
- ii) The "President" means the President of the Governing Body.
- iii) The "Vice-President" means the Vice-President of the ordinary members of the Society.
- iv) The "General Body" means the General Body of the ordinary members of the Society.
- v) The "Secretary" means the Secretary of the Governing Body.
- vi) The "Assistant Secretary" means the Assistant Secretary of the Society appointed by the Governing Body.
- vii) The "Treasurer" means the treasurer of the Society appointed for keeping the treasury/ fund of the Society.

4. Symbol :


Its symbol approved by Governing Body shall be used in all official transactions. The symbol has already been approved by the Registrar of Trade Marks, India, Kolkata vide Trade Mark No. 2325384 dated 02/05/2012.


5. Area of Operation

The Jurisdiction of the Society operation shall be throughout the state of Odisha and other places.

This 'ORGANISATION' shall be open to all Genders without any distinction of any caste ,creed ,race, religion and lingual groups etc.

7. Membership :

No person being

- a. an undischarged insolvent; or
- b. convicted of offence involving moral turpitude; or
- c. of unsound mind; or
- d. a minor shall be eligible to be a member of the Society.

8. General Body :

The General Body of the Society shall be composed of all the members of the ORGANISATION who are not disqualified by the Resolution of the Governing Body.

9. Members:


- (a) Persons who signed the Memorandum of Association or the Members Register shall be the members of the Society and shall continue to be such member so long as they are members of the General Body
- (b) Any person who is elected or co-opted to the General Body shall IP SO FACTO become a member of the Society and shall continue to be such members so long as he is on the General Body.
- (c) Members alone shall have the right to vote and elect members of the Governing Body.

10. Roll of Members :

The Society shall maintain a roll a members and every member shall sign the roll and shall state therein his occupation and address. But if he/she fails to notify any change in this such address as recorded on the roll of members shall be deemed his/her address.

11.. Term of Office


- (i) An ordinary member of the Society may resign his office by a letter addressed to the Society President but his resignation shall be given effect only on its acceptance by the Governing Body.
- (ii) An ordinary member of the Society shall cease to be a member if he/she shall die, become unsound in mind, insane, incapable to act, or insolvent/bankrupt or is convicted of criminal offence involving moral turpitude, resign, retire and/or if he/she does not attend three consecutive meetings of the Society without permission of the President.

12. Membership Fee :

The Governing Body may have such membership fee for the different members as it might think fit from time to time.

13. Patrons:

The Persons, who shall contribute substantially(as shall be decided by the Governing body from time to time), may it be in cash or kind to the organisation shall be regarded as patrons and their name shall be displayed in the notice board of the organisation after approval of the President.

14. Advisory Board

There shall be an advisory board of the Society comprising maximum five persons from other than the members of the association which shall be selected by the President who will guide the Society in its all-round development and the members of which shall change from time to time. However, such advice may not be binding on the Society unless it is approved in the General Body Meeting passed by the 2/3 rd majority of members present.

15. Meeting :

(i) The Annual General Meeting of the Society shall be held after the expire of each calendar year at such date/time and place as may be determined by the Governing body.

(ii) The Business of the Annual general Meeting shall be :-

(a) To receive and adopt the audited statement of accounts and the annual report of the Society.

(b) To consider the budget estimates prepared by the Governing Body.


(c) To appoint auditors.

(d) To transact such other business which may be brought before the meeting by the Governing Body.

(e) Except as otherwise provided in these rules ,all meetings of the Society shall be called by notice under the hand of the Secretary.

16. Governing Body :

a. There shall be a Governing body(GB) comprising of at least 5(Five) members and maximum 9(Nine) members as President, Secretary, Vice-president ,Assistant secretary, Treasurer and others as members which may be changed from time to time by the general body by mode of election/ selection.

- b. A person has to give his/her consent to act as such member in GB before being selected/elected to such office.
- c. Governing Body has the right to reject the membership of a member of the Governing Body if he remains absent for three consecutive GB meetings without any valid reasons.

17. President :

There shall be a President of the Society who will be either selected or elected by the general body of the Society. However, **Swami Shankarananda Giri** will be the President during his life period unless he opts to relinquish the position.

18. Function and Powers of the President :

- (i) The President shall preside over the meetings of the Society.
- (ii) He shall co-ordinate the working of the sub-committee of the Governing Body for efficient management of the Society.
- (iii) On all such matters as the President thinks fit are of sufficient importance and urgency and cannot wait being placed before the next meeting of the Governing Body and which he anticipates would be the approval of the Governing Body the President shall take decisions and place the same before the Governing Body at its next meeting.
- (iv) In case at the meeting of the Governing Body the votes for and against a particular issue are equal, the President shall exercise his casting vote.
- (v) The President may in writing delegate such of his powers as he may consider to the Vice-president, the Secretary or the other member of the Society.
- (vi) The President shall be entitled to invite any other person, any member to attend the meeting of Governing Body but such persons shall have no powers of voting.
- (vii) The President may direct the Secretary to call a special meeting at a short notice in case of emergency.

19. Function and Powers of Vice-President :

- (i) There shall be a Vice-president of the Society selected or elected by the member.
- (ii) The Vice-President will discharge all his/her duties and responsibilities and exercise all the power and privileges of the President in his long absence/leave, his visit aboard or in exigency subject to post facto approval by the President.



Secretary :


- (i) There shall be a Secretary of the Society selected or elected by the members, subject to the approval of the President.
(ii) The Secretary shall be the Principal Governing officer and Accounts officers of the Society.

21. Function and Power of the Secretary :

- i. It shall be the duty of the Secretary to co-ordinate and keep general supervision over all the day to day management of the organisation.
- ii. He/ She shall prescribe the duties of all officers and staff of the Society, give them appropriate instruction and shall exercise such supervision and disciplinary control as may be necessary.
- iii. The Secretary shall exercise his/her powers under the direction of the President of the Governing Body.
- iv. He/ she shall in concurrence with the appropriate authority convene the meeting of the Governing Body, Annual and General meeting and Extra ordinary General meetings, prepare minutes and circulate those among concerned members and authorities.
- v. He/she shall sign all deeds and documents on behalf of the organisation.
- vi. He/she shall be responsible for co-ordination with other Societies having same aims and objectives.
- vii. In case of any litigation the Society shall sue and be sued by the Secretary.
- viii. Any document, litigation or proceedings requiring authenticity by the Society shall be signed by the Secretary or by the other members selected by the President for specific purpose.
- ix. The Secretary shall be responsible for the execution of all policy laid down by the Governing Body and shall attend to all statutory requirement imposed on the Society.
- x. The Secretary will report to the Governing Body on policy matters to the Director of Directive Board for day-to day working and he/she can delegate his/her responsibilities to other officers with the approval of the President.
- xi. The Secretary shall open and operate such Banking Accounts is thought fit for the sake of the Society with the joint signature of the President/ Vice President/ Treasurer of the Society with the approval of the Governing Body/ Executive Committee.
- xii. The Secretary shall be responsible for all money receipt and payment made by the Society in consultation with the Treasurer. He/She shall keep an overall control of the funds of the Society and manage them properly keeping in view of the rules and regulations and the policies laid down by the Governing Body.
- xiii. He/ she shall sign the annual statement of account prepared by the Treasurer and get them audited for presentation before the Governing Body.

- (i) There shall be an Assistant Secretary of the Society selected or elected by the members.
- (ii) Assistant Secretary will officiate as Secretary on his/her absence.

23. Functions and Powers of Assistant Secretary :


- (i) The Assistant Secretary shall exercise all powers and responsibilities as members and privilege and discharge such duties and responsibilities as may be assigned to him by the Secretary with the approval of President.
- (ii) He/ she shall exercise all powers of the Secretary during his/her long absence/leave or visit abroad.

24. Treasurer:


- (i) There shall be a treasurer of the society elected by the members.
- (ii) The Treasurer shall be responsible for the control of cash and bank accounts under the direct supervision of the Secretary and shall prepare the annual accounts and place the same before the audit with the signature of the Secretary on it.
- (iii) He/ she shall open and operate bank account(s) jointly with the President/ Vice- President and Secretary of the organisation.

25. Role of Governing Body/ Executive Body:


- (i) The General Supervise direction and control of the affairs and funds of the society shall be vested in the Governing Body which may exercise all powers and detail acts and things which may be exercised or done by the Society.
- (ii) Without prejudice to the generality of the power under rule 25(i) above the Governing Body shall determine.
 - (a) The terms and conditions applicable to the admission of different categories of members.
 - (b) The procedure for election of the members of the Board and liable to retire.
 - (c) The fees and allowances that may be paid to the non-official members of the Board/Committees and other special invitees.
 - (d) The preparation and sanction of budget estimate and delegation of powers as regard to sanction of expenditure entering into contracts and investments of the funds of the Society.
 - (e) The establishment and maintenance of provident or other benefit funds of officers and other employees of the Society
 - (f) Formation of other Committee/ Sub committee for resolving cases/ handling different functions in the organisation, the number of members of which shall be at least 3(three).
 - (g) Any other matter which is to be or may be provided .The General Body shall have the power to make ,adopt ,amend alter the Bye-law as it may find necessary for the management of the affairs of the Society.


26.Meeting of the Governing Body/Committee :


- (i) The Governing Body or any Committee constituted shall meet at such time and one places as may be determined by the Governing Body or the Committee as the case may be.
- (ii) The President may convene special meeting and Governing body meetings of the Society when ever he thinks fit.
- (iii) Every notice calling a meeting of the Society shall state the time and place at which such meeting will be held and shall be served upon every member of the Society not less than seven days before the day appointed for the meeting. The accidental omission to give or non receipt of such notice by any member shall not invalidate the proceedings of any such meetings.
- (iv) Every meeting of the Society shall be presided over by the President and in his absence by Vice- President.
- (v) In the absence of the both the President and Vice-president at the meeting of the Society ,the members of the society shall choose one of the members present to be the President of the meetings.
- (vi) **One third(1/3rd)** of the Members of the Governing Body present in person shall form a **QUORUM** at every meeting of the Governing Body. A fraction contained in that one-third shall be rounded off as one. In case there is no quorum at the appointed time, the meeting shall stand adjourned. The Meeting may however begin after half and hour of the adjournment at the same place. In the case of such adjournment meeting, no quorum will be required.
- (vii) **Two third(2/3rd)** members of Governing Body can bring "No Confidence Motion" against the Secretary, Asst. Secretary or Treasurer and that will attract the attention of the President.
- (viii) All discussions at the meeting of the Society shall be determined by majority vote. Each member shall have one vote and the President of the meeting shall have a second or casting vote.


27..Staff of the Organisation :

The Office Manager required for looking after the day to day working of the organisation including finalisation of projects and their implementation will be appointed by the Governing Body.


- (i) In the event of there being vacancy or invalidation in the office of the Office Manager or is unable to discharge his function owing to illness or any other case the Secretary may otherwise appoint any person to officiate the post with the approval of the President.
- (ii) Separate rules and regulations shall be prepared by the Governing Body as to staff appointment sanction and creation of post, sanction of salary ,leave and other facilities from time to time.

28. Stock Register of Society's belongings :

- (i) There shall be a stock register of Organisation's belongings.
- (ii) Secretary shall see that all belongings are recorded in stock register properly.

29. No act or proceedings of the Society or its Governing Body shall be deemed to be invalid by reason merely of any vacancy in or any defect in constitution of the Society or the Governing Body of Society as the case may be.

30. IMPEACHMENT:-

All the members except the Life President **Swami Shankarananda Giri** can be impeached from his/her post, including the initial membership of the Society by the **2/3rd majority** members of the General Body meeting of the Society specially called for the same purpose by the Life President **Swami Shankarananda Giri**.

31. Accounts :


- (i) The Society shall cause to be maintained such books of accounts and other books in relation to its accounts such form and in such manner as per the Society Act, Rules and Regulations.
- (ii) The financial year of the Society shall be from that 1st of April of each year to the 31st March of the next year.
- (iii) The Society shall as soon as may after closing the Annual Accounts prepare a statement of accounts in such form as the Board may in consultation with the Auditors of Societies appointed by the General Body.
- (iv) A copy of each of the Annual Accounts of the Society together with the audit report there on and a report of the proceedings on all works undertaken during the year shall be furnished to the ordinary members of the Society.

32. Funds of the Society :

The funds of the Society will consist of the following :

- (i) Grant received from State Government.
- (ii) Grants received from Govt of India.
- (iii) Grants/Donations from foreign entities/persons(subject to FCRA guidelines)
- (iv) Fees from members and others
- (v) Donations / Contribution from members and others
- (vi) From any other sources not defined above.

The funds of the Society shall be kept in a bank account(s) which shall be opened and operated by a person(s) authorised by the Governing body as per this Bye laws and the investment of such fund of the Society shall be made in the manner as described in section 11(5) of the Income Tax Act'1961 as amended from time to time. The same will be utilised for the purpose of the Society.

33. Audit :

- (i) The Society shall maintain proper accounts and other relevant records and prepare an annual statement of accounts in such form as may be prescribed by the Governing Body.
- (ii) The audited statement of account together with the audit report will be placed before the Governing Body for consideration and approval and there after the same shall be put up before the General Body.
- (iii) The Accounts of the Society shall be audited annually by a firm of Chartered Accounts to be appointed by the General Body.
- (iv) The controller and auditor General of India shall however have the right to demand the production of books, accounts connected vouchers and other documents of papers in respect of grants/loans made by the States and Government of India to the Society.

34. Annual Report :

A draft of the Annual Report and the yearly account of the Society shall be prepared by the Secretary for the consideration of the Governing Body and shall there after be placed before the Society at its Annual General Meetings for consideration and approval. Copies there of finally approved by the Society shall be supplied to the members of the Society. The proceedings of the Society together with the Annual Report shall be sent to the concerned authorities and to the members of the Society for information.

35. Service of Notice :

- (i) A notice may be served upon any member of the Society either personally or through email, the Regd. post or Speed post in an envelope addressed to such member of the address mentioned in the role of members.
- (ii) Any notice so served by the post shall be deemed to have been served on the day following that on which the letter envelop or paper containing the same is posted and in providing such services if shall be sufficient to prove that the cover containing such notice was properly addressed and put into the Post Office.

36. Alteration of Extension of the object(s) of Society /Society :


The Society may alter, amend, modify, extend or abridge the object(s) for which it is established as per the provisions of Societies Registration Act XXI of 1860.


37. Amendments of the Rules & Memorandum of Association :

The rules of the Society may be altered at any time by resolution passed by **3/5th majority** of members of the Society presented at any meeting of the Society which shall have been clearly convened for the purpose as per section 12 and 12(a) of the Society Registration Act XXI of 1860. A copy of such amended rules & memorandum shall be filed by the Governing Body with the Office of the Registrar of Societies.

38. Indemnity :

Every officer of the Society shall be indemnified out of the funds of the Society against all losses and expenses incurred in the discharge of his/ her duties except such as shall happen through his/ her own neglect ,wilful act or default ,and such one shall be answerable only for his/her own act ,negligence or defaults and not those of any other person.

39.Change of Name :

The Society may change its name by special resolution passed by 3/5th majority of General Body members of the Society present at special called meeting of the Society which shall have been duly convened for the purpose and a copy of resolution will be sent to the concerned Registered Authority.

For the purpose of Section 6 of the Societies Registration Act. XXI of 1860 the person in whose name the Society may issue or be issued shall be the Secretary of the Society.


40. Dissolution :

- (i) The Society shall not be dissolved unless **three- fifth(3/5th)** of the members have expressed a wish for dissolution by their votes delivered in person or by proxy at a General Meeting convened for the purpose.
- (ii) Upon dissolution of the Society its assets will be handed over to similar registered Society or to the Government after clearing up all its debts and liabilities and no members shall be entitled to receive any profit out of it.
- (iii) However, when ever any Government is a member is a member in any society registered under this Act, such society shall not be dissolved without the consent of the Government.

41.Legal Action :

The Secretary may **sue or be sued** on behalf of the Society for any act of the Society and/or for movable or immovable property.




